ABOUT THE INFORMATION COMMISSIONER



An independent and autonomous body that protects, monitors and promotes the right of citizens to access public information on the basis of the Right of Access to Information Act.

THE BASIC ROLE OF THE INFORMATION COMMISSIONER IS TO:

- ▶ PROTECT the right of citizens to access information,
- ▶ PROMOTE the right of access to information of the public and
- ▶ CARRY OUT monitoring over the implementation of the Right of Access to Information Act

THE RIGHT OF ACCESS TO INFORMATION ACT (OG 25/2013, 85/2015)

- ▶ Regulates the right of access to information and the re-use of information owned by public authorities
- ▶ Obligations of public authorities - Article 10



ABOUT THE OFFICE



The Central State Office for the Development of the Digital Society was established according to the Act on the organization and jurisdiction of the ministries and other central state administration bodies (OG 93/2016), which entered into force on 16 October 2016.

DESCRIPTION: The implementation of the project Adjustment of Public Authorities Information Systems to the Open Data Portal, which was started on 28 May 2019, will technologically and visually improve the Open Data Portal (data.gov.hr), enable the adjustment of IT systems of public authorities, increase the quality of public authorities data sets publication and enlarge the number of open data set users while strengthening the capacities of state and public administration.

PROJECT OBJECTIVE: To upgrade the open data system (portal), influence the increased publication of open data sets in public authorities as well as on the Open Data Portal, and consequently, the re-use of open data sets by targeted project beneficiaries and other stakeholders.

WHAT ARE OPEN DATA?

- ▶ Data which can be easily accessed, re-used and shared with anyone - with reference to the author and associates who created the data and distributed under the same conditions
- ▶ As a basis of the Open Government concept, they represent data created by public authorities, whose use for both commercial and/or non-commercial purposes may create added social or economic value (applications, scientific research, and the like)
- ▶ Do not contain personal information nor other legally protected information
- ▶ Need to be in open formats and machine-readable.

WHAT ARE PUBLIC AUTHORITY BODIES?



“Public authority bodies”, for the purpose of the Right of Access to Information Act, are the public authorities, other state authorities, bodies of the local and regional self-government units, legal entities and other persons vested with public authority, legal entities established by the Republic of Croatia or the local and regional self-government units, legal entities engaged in public service, legal entities entirely funded by the state budget or the budget of the local and regional self-government units or from public resources (taxes, contributions, etc.), and companies in which the Republic of Croatia or the local and regional self-government units hold individual or joint majority ownership.



WHAT IS THE RE-USE OF INFORMATION?

“Re-use” is the use of the public authority information by natural persons or legal entities, for commercial or non-commercial purposes different from the original purpose within the public purpose for which this information was created, and which is realised within the frame of the law or other scope prescribed by the regulations, or business that is generally considered a public affair.

HOW TO OBTAIN INFORMATION FOR RE-USE?



- Look for it on the Open Data Portal (data.gov.hr)
- On the city open data portal, if it exists
- On the actual web page of the public authority



ABOUT THE OPEN DATA PORTAL



- ▶ Central spot for the collection, classification and distribution of public authorities' open data
- ▶ Single point of access to open data for re-use by all citizens
- ▶ Metadata catalogue that makes it easier to search for open data
- ▶ Set up in March 2015 pursuant to the Right of Access to Information Act (OG 85/2015)
- ▶ Within the jurisdiction of the Central State Office for the Development of Digital Society since 2018.



CONTENTS OF THE PORTAL

- Data sets published in machine-readable and open format (RDF, XML, HTML, JSON, CSV), which means that they can be read by a machine (computer) and interpreted by open or closed source software
- List of bodies that publish data sets on the Open Data Portal
- Applications developed based on open data sets published on the Open Data Portal
- Documents and other materials on open data
- Glossary

mini service for finding a kindergarten in the area of the City of Zagreb and its surroundings, and soon in other major cities

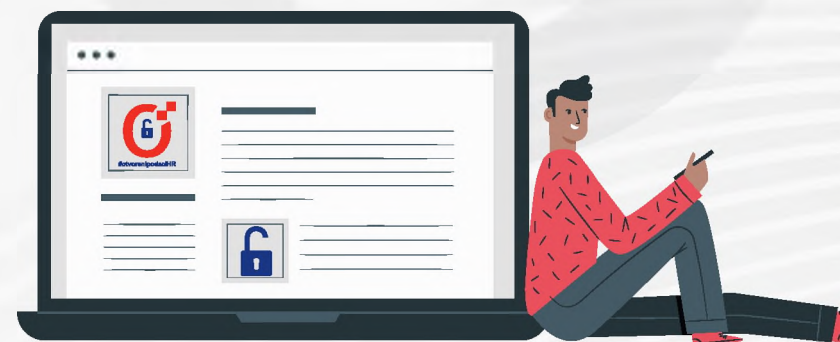

OPEN DATA POLICY



Open Data Policy was adopted in July 2018 by the Government of the Republic of Croatia and it represents an umbrella document with unified and elaborated access to open data at national level.
